The text of the original articles has an introduction, materials and methods, results, discussion and conclusions.

Introduction. To formalize the introduction, the format of the C.A.R.S. model (Create a Research Space) is adopted, according to which you need to: (i) mark the territory and highlight the relevance of the selected topic; (ii) point to a gap in the field of knowledge and raise the problem; (iii) form a goal.

Materials and methods

This section should include the design of the study; the description of the participants (inclusion/exclusion criteria) or the type of material used in the work; the description of all activities undertaken and the type of statistical analysis. In this section, the author must state that the study is in accordance with the basic ethical principles.

Results

This section should describe the data obtained and the results of the statistical analysis without interpretation. The results should be presented logically in text, tables and/or figures.

Discussion

This section should include an interpretation of the research results. These data need to be discussed in the context of other studies described in the literature. The discussion can also present the strengths and weaknesses of the study

Conclusions

The conclusions should relate to the objectives of the study and be presented in a single paragraph. Conclusions should contain qualified statements and confirmed data by the authors. Conclusions should not contain abbreviated words.

Conflict of interest. Authors must declare that there is/is no conflict of interest. If there is a conflict of interest, the lead author must file a conflict of interest application.

Contribution of the authors. This is a mandatory section of the manuscript. In this section it is necessary to specify the contribution (intellectual attachment) of each author in the work on the article. This section specifies the role of the individual participant according to the taxonomy of the CRediT participants (Contributor Roles Taxonomy), followed by the first letters of the author/s who contributed.

Section filling example:

Conceptualization - G.O.; methodology - A.S.; verification - G.O.; formal analysis - G.O., J.S. and B.A.; writing (original rough preparation) - G.O.; writing (review and editing) - J.S.

All authors read, agreed with the final version of the manuscript and signed the form of transfer of copyright.

Bibliography

The list of references should be shown on a separate sheet with double interval. The literature used should be sequentially numbered in the order in which it was first mentioned in the text. The reference number should be placed in square brackets at the end of the sentence before the point. The link to the scientific article should contain the following information: authors, article title, journal title, year, volume/issue, first and last pages of the article. References to the book should include only the year of publication and the number of pages. At the end of each source, you must insert a numeric object identifier (DOI). A literary source published in Kazakh or Russian must have a Latin transliteration.
